- Community Support: Preference is given to travel businesses that promote local economies, employ fair labour practices and uphold cultural integrity.
- Low-Impact Initiatives: We prioritise accommodations and tours with ecocertifications (e.g., EarthCheck, Green Key) that actively reduce their environmental footprint.

3. Verification Process

EcoSplash uses a combination of manual review, self-assessment and AI-driven verification to evaluate each listing's sustainability credentials. Businesses are required to complete a sustainability questionnaire and responses form part of their public profile.

Key elements include:

- **Transparency**: Businesses are required to disclose their sustainability practices, which are visible to consumers.
- **Continuous Improvement**: We refine our standards regularly, with businesses expected to meet any updated criteria over time.
- User Feedback and Accountability: Consumers can review and provide feedback on listings, helping to hold businesses accountable to their sustainability claims.
